

104 Corporation Reports May 2016 Consolidated Revenue of NT\$ 129 Million

Taipei, Taiwan, R.O.C., June 13, 2016 --- 104 Corporation (TSE:3130), a leading provider of integrated human resource services in Taiwan, today announced its consolidated revenue for May 2016 amounted to NT\$ 129 million, decreased by NT\$ 108 million and 45.52% respectively compared to the corresponding month in the preceding year. The accumulated revenue totaled NT\$ 593 million, decreased by NT\$ 465 million and 43.92% compared to the same period in 2015.

The revenue decrease was mainly attributed to the sale of the temporary staffing subsidiary, being aligned with the transformation strategy of the corporate development plan. The consolidated revenue decreased by 6.57% compared to the same month in the previous year excluding temporary staffing business, and the accumulated revenue increased by 4.13% compared to the same period in 2015 excluding temporary staffing business.

The revenue of online business group for May 2016 decreased by 12.41% year-over-year to NT\$ 107 million, which accounted for 82.98% of the consolidated revenue. The accumulated revenue of online business group increased by 4.43% compared to the same period in 2015 to NT\$ 503 million, which accounted for 84.75% of the consolidated revenue.

The revenue of consultation service business group accounted for 17.02% of the consolidated revenue, decreased by 80.84% to NT\$ 22 million on a year-over-year basis. The accumulated revenue of consultation service business group accounted for 15.25% of the consolidated revenue, decreased by 84.30% to NT\$ 90 million compared to the same period in 2015. The revenue of consultation business group for May 2016 increased by 38.40% compared to the same month in the previous year excluding temporary staffing business, and the accumulated revenue of consultation service business group increased by 2.53% compared to the same period in 2015 excluding temporary staffing business.
