

104 Corporation Reports June 2016 Consolidated Revenue of NT\$ 127 Million

Taipei, Taiwan, R.O.C., July 11, 2016 --- 104 Corporation (TSE:3130), a leading provider of integrated human resource services in Taiwan, today announced its consolidated revenue for June 2016 amounted to NT\$ 127 million, decreased by NT\$ 101 million and 44.18% respectively compared to the corresponding month in the preceding year. The accumulated revenue totaled NT\$ 720 million, decreased by NT\$ 565 million and 43.97% compared to the same period in 2015.

The revenue decrease was mainly attributed to the sale of the temporary staffing subsidiary, being aligned with the transformation strategy of the corporate development plan. The consolidated revenue for June 2016 increased by 3.24% compared to the same month in the previous year excluding temporary staffing business, and the accumulated revenue increased by 3.97% compared to the same period in 2015 excluding temporary staffing business.

The revenue of online business group for June 2016 increased by 6.76% year-over-year to NT\$ 108 million, which accounted for 85.19% of the consolidated revenue. The accumulated revenue of online business group increased by 4.83% compared to the same period in 2015 to NT\$ 611 million, which accounted for 84.83% of the consolidated revenue.

The revenue of consultation service business group accounted for 14.81% of the consolidated revenue, decreased by 85.10% to NT\$ 19 million on a year-over-year basis. The accumulated revenue of consultation service business group accounted for 15.17% of the consolidated revenue, decreased by 84.45% to NT\$ 109 million compared to the same period in 2015. The revenue of consultation business group for June 2016 decreased by 13.24% compared to the same month in the previous year excluding temporary staffing business, and the accumulated revenue of consultation service business group decreased by 0.58% compared to the same period in 2015 excluding temporary staffing business.
