

104 Corporation Reports October 2016 Consolidated Revenue of NT\$ 124 Million

Taipei, Taiwan, R.O.C., November 10, 2016 --- 104 Corporation (TSE:3130), a leading provider of integrated human resource services in Taiwan, today announced its consolidated revenue for October 2016 amounted to NT\$ 124 million, decreased by NT\$ 81 million and 39.38% respectively compared to the corresponding month in the preceding year. The accumulated revenue totaled NT\$ 1,228 million, decreased by NT\$ 919 million and 42.82% compared to the same period in 2015.

The revenue decrease was mainly attributed to the sale of the temporary staffing subsidiary, being aligned with the transformation strategy of the corporate development plan. The consolidated revenue for October 2016 increased by 8.25% compared to the same month in the previous year excluding temporary staffing business, and the accumulated revenue increased by 4.22% compared to the same period in 2015 excluding temporary staffing business.

The revenue of online business group for October 2016 increased by 5.14% year-over-year to NT\$ 103 million, which accounted for 83.02% of the consolidated revenue. The accumulated revenue of online business group increased by 3.80% compared to the same period in 2015 to NT\$ 1,039 million, which accounted for 84.61% of the consolidated revenue.

The revenue of platform and consultation business group accounted for 16.98% of the consolidated revenue, decreased by 80.26% to NT\$ 21 million on a year-over-year basis. The accumulated revenue of platform and consultation business group accounted for 15.39% of the consolidated revenue, decreased by 83.52% to NT\$ 189 million compared to the same period in 2015. The revenue of platform and consultation business group for October 2016 increased by 26.54% compared to the same month in the previous year excluding temporary staffing business, and the accumulated revenue of platform and consultation business group increased by 6.61% compared to the same period in 2015 excluding temporary staffing business.
