

104 Corporation Reports December 2016 Consolidated Revenue of NT\$ 110 Million

Taipei, Taiwan, R.O.C., January 10, 2017 --- 104 Corporation (TSE:3130), a leading provider of integrated human resource services in Taiwan, today announced its consolidated revenue for December 2016 amounted to NT\$ 110 million, decreased by NT\$ 93 million and 45.67% respectively compared to the corresponding month in the preceding year. The accumulated revenue totaled NT\$ 1,455 million, decreased by NT\$ 1,099 million and 43.03% compared to the same period in 2015.

The revenue decrease was mainly attributed to the sale of the temporary staffing subsidiary, being aligned with the transformation strategy of the corporate development plan. The consolidated revenue for December 2016 decreased by 4.01% compared to the same month in the previous year excluding temporary staffing business, and the accumulated revenue increased by 3.26% compared to the same period in 2015 excluding temporary staffing business.

The revenue of online business group for December 2016 decreased by 0.32% year-over-year to NT\$ 93 million, which accounted for 84.54% of the consolidated revenue. The accumulated revenue of online business group increased by 3.37% compared to the same period in 2015 to NT\$ 1,229 million, which accounted for 84.45% of the consolidated revenue.

The revenue of platform and consultation business group accounted for 15.46% of the consolidated revenue, decreased by 84.42% to NT\$ 17 million on a year-over-year basis. The accumulated revenue of platform and consultation business group accounted for 15.55% of the consolidated revenue, decreased by 83.43% to NT\$ 226 million compared to the same period in 2015. The revenue of platform and consultation business group for December 2016 decreased by 20.19% compared to the same month in the previous year excluding temporary staffing business, and the accumulated revenue of platform and consultation business group increased by 2.69% compared to the same period in 2015 excluding temporary staffing business.
