

104 Corporation Reports March 2017 Consolidated Revenue of NT\$ 138 Million

Taipei, Taiwan, R.O.C., April 10, 2017 --- 104 Corporation (TSE:3130), a leading provider of integrated human resource services in Taiwan, today announced its consolidated revenue for March 2017 amounted to NT\$ 138 million, decreased by NT\$ 4 million and 2.76% respectively compared to the corresponding month in the preceding year. The accumulated revenue totaled NT\$ 361 million, increased by NT\$ 16 million and 4.79% compared to the same period in 2016.

The revenue of online business group decreased by 5.35% year-over-year to NT\$ 116 million, which accounted for 84.14% of the consolidated revenue. The accumulated revenue of online business group increased by 3.82% compared to the same period in 2016 to NT\$ 305 million, which accounted for 84.50% of the consolidated revenue.

The revenue of platform and consultation business group accounted for 15.86% of the consolidated revenue, increased by 13.70% to NT\$ 22 million on a year-over-year basis. The accumulated revenue of platform and consultation business group accounted for 15.50% of the consolidated revenue, increased by 10.45% to NT\$ 56 million compared to the same period in 2016.
