

104 Corporation Reports August 2017 Consolidated Revenue of NT\$ 135 Million

Taipei, Taiwan, R.O.C., September 11, 2017 --- 104 Corporation (TSE:3130), a leading provider of integrated human resource services in Taiwan, today announced its consolidated revenue for August 2017 amounted to NT\$ 135 million, decreased by NT\$ 0.28 million and 0.2% respectively compared to the corresponding month in the preceding year. The accumulated revenue totaled NT\$ 1,027 million, increased by NT\$ 40 million and 4.02% compared to the same period in 2016.

The revenue of online business group decreased by 0.29% year-over-year to NT\$ 111 million, which accounted for 82.25% of the consolidated revenue. The accumulated revenue of online business group increased by 2.2% compared to the same period in 2016 to NT\$ 854 million, which accounted for 83.18% of the consolidated revenue.

The revenue of platform and consultation business group accounted for 17.75% of the consolidated revenue, increased by 0.21% to NT\$ 24 million on a year-over-year basis. The accumulated revenue of platform and consultation business group accounted for 16.82% of the consolidated revenue, increased by 14.05% to NT\$ 173 million compared to the same period in 2016.
