

104 Corporation Reports September 2017 Consolidated Revenue of NT\$ 130 Million

Taipei, Taiwan, R.O.C., October 11, 2017 --- 104 Corporation (TSE:3130), a leading provider of integrated human resource services in Taiwan, today announced its consolidated revenue for September 2017 amounted to NT\$ 130 million, increased by NT\$ 13 million and 11.25% respectively compared to the corresponding month in the preceding year. The accumulated revenue totaled NT\$ 1,156 million, increased by NT\$ 53 million and 4.79% compared to the same period in 2016.

The revenue of online business group increased by 6.98% year-over-year to NT\$ 107 million, which accounted for 82.51% of the consolidated revenue. The accumulated revenue of online business group increased by 2.71% compared to the same period in 2016 to NT\$ 961 million, which accounted for 83.11% of the consolidated revenue.

The revenue of platform and consultation business group accounted for 17.49% of the consolidated revenue, increased by 37.1% to NT\$ 23 million on a year-over-year basis. The accumulated revenue of platform and consultation business group accounted for 16.89% of the consolidated revenue, increased by 16.33% to NT\$ 195 million compared to the same period in 2016.
