

104 Corporation Reports October 2017 Consolidated Revenue of NT\$ 132 Million

Taipei, Taiwan, R.O.C., November 10, 2017 --- 104 Corporation (TSE:3130), a leading provider of integrated human resource services in Taiwan, today announced its consolidated revenue for October 2017 amounted to NT\$ 132 million, increased by NT\$ 8 million and 6.14% respectively compared to the corresponding month in the preceding year. The accumulated revenue totaled NT\$ 1,288 million, increased by NT\$ 60 million and 4.92% compared to the same period in 2016.

The revenue of online business group increased by 1.86% year-over-year to NT\$ 105 million, which accounted for 79.67% of the consolidated revenue. The accumulated revenue of online business group increased by 2.63% compared to the same period in 2016 to NT\$ 1,066 million, which accounted for 82.76% of the consolidated revenue.

The revenue of platform and consultation business group accounted for 20.33% of the consolidated revenue, increased by 27.09% to NT\$ 27 million on a year-over-year basis. The accumulated revenue of platform and consultation business group accounted for 17.24% of the consolidated revenue, increased by 17.53% to NT\$ 222 million compared to the same period in 2016.
